Budget Update as of 30 September 2024

Total income to date is \$3,455 (\$859 in Chapter Dues and \$2,596 net from Chapter Ways and Means Fundraiser). Dues are a direct deposit monthly from NARFE National Headquarters. The Budget was calculated with a membership of 193 however the current membership is 184. The projected dues receipt for this FY was \$1,717. Based on the current membership, I am projecting an additional \$778 in dues income. The Chapter Liability Insurance, Post Office Box Rent, and Document Storage have all been paid for the 12-month period after they became due. The reimbursement for FEDcon-24 was 82% of the budgeted amount. Based on the information available, there are sufficient funds available for committee expenses budgeted for FY2024-25.


#### NARFE MEMBERSHIP DRIVE ENDS DECEMBER 24<sup>TH</sup>

NARFE-PAC contributions are not deductible for federal income tax purposes.

# CPI-W FIGURE FOR SEPTEMBER 2024 WILL RESULT IN 2.5 PERCENT COLA IN 2025 FOR CSRS RETIREES AND 2.0 PERCENT COLA FOR FERS EMPLOYEES



The Consumer Price Index for Urban Wage Earners and Clerical Personnel (CPI-W), used to determine if Social Security recipients, federal retirees, and survivor annuitants will receive a Cost-Of-Living-Adjustment (COLA) in January 2025, showed a minimal increase of 0.13 percent for the month of September 2024. The September 2024 figure was 309.046, and the average CPI-W for the third quarter of 2024 (July-September) was 308.729. In order for a COLA to be authorized in January 2025, the average CPI-W for July-September 2024 (308.729) must exceed the average CPI-W for the months of July-September 2023, which was 301.236. This means that Social Security recipients, and federal retirees under the Civil Service Retirement System (CSRS) will receive a 2.5 percent COLA in January 2025. Federal retirees under the Federal Employees Retirement System (FERS) will receive a 2.0 percent COLA in January 2025, since FERS COLAs are capped at 2 percent when the CPI-W increase is between 2 and 3 percent. The CPI-W for October 2024 is scheduled to be released on November 13, 2024 by the Bureau of Labor Statistics (BLS).

# FEHBP OPEN SEASON FOR THE 2025 BENEFITS YEAR ON THE HORIZON

The Federal Employees Health Benefits (FEHBP) Open Season for the 2025 benefits year will begin on Monday, November 11 and conclude on Monday, December 9. NARFE members are reminded that the various health plan providers no longer automatically mail paper copies of plan brochures to those currently enrolled in these plans. To request a paper copy of your plan's brochure, you must follow any instructions your health insurance provider gives you. If you have any questions, call the customer service number on your health insurance ID card. The Office of Personnel Management (OPM) website will contain on-line versions of each plan's brochures when they are released as well as valuable information related to the Open Season.

NARFE members are reminded that representatives from various federal health benefits plan providers will be present at the NARFE Chapter 182 monthly membership meeting on 9 November to answer questions and to make brief presentations about these plans. The October edition of the NARFE magazine contains a preview of the upcoming Open Season on pages 48-54. More detailed information will be presented in both the *NARFE* monthly magazines for November and December 2024 and in the NARFE Chapter 182 newsletter.
