Legislation (Janice Bridges)

Hope everyone had a great Christmas and a Happy New Year! Of course, the BIG news is that President Biden signed H.R. 82 into law. This repeals the Government Pension Offset and Windfall Elimination Provision. Those affected will receive a back payment for 2024. Now we need to focus on the next issues. Especially the Equal COLA Act, which provides FERS with the same Cost of Living as CSRS. There has not been a new number assigned to it yet. Once we find out we will let you all know.

NARFE-PAC will report final contribution and disbursement numbers for the 2023-2024 cycle in February.

With the start of the 2025 – 2026 cycle, we will have new chapter and national goals, which I will present in the near future. In addition, the PAC has a new lapel pin design. After the historic win repealing the WEP and GPO, NARFE-PAC continues its fight for our earned benefits as there are other emerging threats on the horizon. That is why it is so important to support the PAC. These threats include cuts to federal benefits, changes to merit-based civil service, workforce reduction, compensation cuts, and unfair COLAs, to name a few. CONSUMER PRICE INDEX SHOWS UNEVEN RESULTS FOR OCTOBER AND NOVEMBER 2024

The Consumer Price Index for Urban Wage Earners and Clerical Personnel (CPI-W), used to determine if Social Security recipients, federal retirees, and survivor annuitants will receive a Cost-Of-Living Adjustment (COLA) in January 2026, showed mixed results based on the CPI-W figures for October and November 2024. The CPI-W figure for October 2024 was 309.385, a 0.1 percent increase over the September 2024 figure, while the CPI-W for November 2024 was 308.998, a slight decline when compared with the October 2024 figure. The CPI-W figure for December 2024 is scheduled to be released on 15 January 2025 by the Bureau of Labor Statistics.

In order for a COLA to be authorized in January 2026, the average CPI-W for the months of July-September 2025 must exceed the average CPI-W figure for the months of July-September 2024, which was 308.729. Social Security recipients and federal retirees under the Civil Service Retirement System (CSRS) received a 2.5 percent COLA in January 2025, while federal retirees under the Federal Employees Retirement System (FERS) received a 2.0 COLA in January 2025, since FERS COLAs currently are capped at 2 percent when the CPI-W increase is between 2 and 3 percent.
